

Smoke Free Zones

COUNCIL POLICY NO. 121

1. POLICY OBJECTIVE

To support the community to become safer and healthier in a smoke-free environment.

2. DEFINITION

'Smoke-free zone' means part of an outdoor area in which smoking is not permitted. The 'smoke-free zone' will be identified by the presence of one or more signs displaying the phrase 'smoke-free zone'. Smoking means smoking, holding or otherwise having control over an ignited smoking product. Smoking product includes any tobacco or other product that is intended to be smoked.

3. POLICY

In the interests of providing a smoke-free environment, smoking will not be permitted in specified public places and Council controlled land, in particular, workplaces, other places used for recreation and places used by children.

The following location have been declared "smoke-free zones" at all times by Gannawarra Shire Council:

- 1. Council controlled infrastructure and buildings, including children centres:
 - (a) All indoor areas;
 - (b) All outdoor dining areas:
 - (c) Within five (5) metres of major thoroughfares and access points to buildings, such as doors, windows, air conditioning vents and air intakes.
- 2. Within five (5) metres of substantially enclosed courtyards and building surrounds.
- 3. Within 10 metres of play equipment, including skate parks.
- 4. Inside the external fence of all swimming pools, including Koondrook and Quambatook swimming pools which are located on Crown land and managed by an appointed Committee of Management.
- 5. Within 10 metres of a sporting venue that is an outdoor public space during an organised underage sporting event or a training practice session to prepare for participation in an organised underage sporting event, or any break or interval during the course of the organised underage sporting event or training or practice session.

Council will erect and maintain in all proclaimed no smoking areas at pedestrian access points, signage that clearly indicates that the area has been declared a "Smoke-free zone".

Adherence to Policy No. 121 – Smoke Free Zones will be enforced by Local Law No.1 – Community Amenity 2012 and will attract a penalty in accordance with Clause 70 of Part 8 of the Local Law No.1 – Community Amenity 2012.

Council will also enforce the requirements of the *Tobacco Act 1987*, and associated amendments, where this Act is applicable. This includes no smoking within enclosed workplaces, outdoor drinking and dining areas, children services, public swimming pools, children's play equipment, skate parks and outdoor sporting venues when organised underage sporting events, training or practice sessions are taking place.

4. POLICY REVIEW

Council will review this policy as required but always within two years after a general election of the Council.

At the time it was developed, this policy was compliance with the *Victorian Charter of Human Rights and Responsibilities Act 2006.*
