


The Early Years Plan has been developed using a range of current research and policy as well as significant input and feedback from community and other early years service partners.

Advocacy and partnerships aim to improve coordination to deliver a collective positive impact on children's health and wellbeing.

Gannawarra Shire is committed to being a pivotal provider and advocate for children in our community. The Municipal Early Years Plan (MEYP) provides an evidence-based approach to planning Council's involvement in social support and change for children aged between birth and 12 years of age. It provides a roadmap for planning services and facilities that will be delivered by the Shire and in collaboration with other partner organisations committed to the support and wellbeing of children.

With a small and currently decreasing population of families with children, spread over large distances, Gannawarra Shire has a challenge in sustainably delivering and advocating for quality children's services, programs and facilities. Gannawarra Shire is a regional leader in the support and care of children in our communities. The Shire is directly involved in the provision of childcare and kindergarten services as a direct and active response to the inherent issues that came from remote or long distance management of these services by third parties.

The Shire has shown a willingness to step into these child service and support spaces where it sees an absence of others doing so- a sign of a leadership and commitment to the wellbeing of it's children.

In an area where populations are inherently small and will remain so for the foreseeable future, area and organisational partnerships are crucial to ensure a coordinated, comprehensive approach to supporting families and children. This collaborative approach is crucial and, through the MEYP,





Our Community Profile

Gannawarra Shire has a small population spread across a large geographic area. The community is generally ageing (as are most communities in Australia) and there has been a slow but consistent diminishing of population over the last decade.

The Shire is remote from a number of main regional cities and obtaining high levels of consistent and timely service delivery is challenging due to travel distances and small population.

The Shire is made up of many smaller satellite townships with the two largest towns being Kerang (approximately 3,700 people) and Cohuna approximately 1,800 people).

Although the Shire population is ageing and has decreased from just over 11,500 to fewer than 10,500 over the past decade, the number of families with children remains significant at approximately 1,380.1 This is a reduction from the 2006 ABS figure of 1,591.

Most recent Census data provides a total of 568 children in the 0-4 year old cohort and 1,323 children in the 5-14 year old cohort (ABS 2011).

This is a reduction from 2006 population levels of 599 children in the 0-4 year old cohort and 1,622 children in the 5-14 year old cohort.

Over the 2006-2011 period, the 0-14 population in Gannawarra Shire has dropped by 33 children.

The number of working parents has also decreased as families have moved from Gannawarra Shire.

Cohuna has experienced significant growth in the 0-4 year old population with an increase from 67 children to 106 between 2006 and 2011. (ABS Census data)

MCH birth data supports this growth in Cohuna. 2009/10 birth data indicates 110 births across the municipality with just 27 from Cohuna with an increase to 113 births in 2013/14 with 44 from Cohuna.

Current Research

There is now an established evidence base of research and government policy regarding the benefits of investing in early years support and development. A summary of key pieces of research and current government policy are provided below.

GLOBAL: Child Friendly Cities Framework

The Child Friendly Cities Framework is a global initiative aimed at translating the United Nations (UN) Convention on the Rights of the Child into action that can be implemented at the local level. The UN Convention was signed by Australia in 1990.

Promoting the concept of putting children first, Child Friendly Cities recognise that the wellbeing of children and young people is a more general indicator of a healthy habitat, and a democratic, well-governed society.

In practice at the local level a Child Friendly City aims to reflect children's rights in policies, laws, programs and budgets.

A key philosophy of the Child Friendly City is also to achieve a more livable city for all members of the community by creating one that is the safest, healthiest, and accommodating for its most vulnerable citizens.

The UNICEF document "Building Child Friendly Cities: A framework for action" provides a broad guide for developing a Child Friendly City and identifies steps to build a local system of governance committed to fulfilling children's rights.²



The UNICEF Framework for Action provides four key principles that could be useful in *all* Council actions. These include:

- **1. Non discrimination-** consider all children regardless of background
- **2. Best interests-** children are a primary consideration in decision making
- 3. Every child's right to life and maximum development
- 4. Listening to children and respecting their views.

NATIONAL: The Australian Education and Development Census

The Australian Early Development Census (AEDC) is a population measure of how young children are developing across Australia, as they begin school. It occurs every three years and is due to be undertaken again in 2015.

Gannawarra Shire results for 2012 show a significant improvement on 2009 figures with children showing vulnerabilities in 2 or more areas decreasing by 5.1 percent and those showing vulnerability in 1 area dropping by 10 percent.

Comparisons with national and state averages is highly encouraging with lower than national averages and similar to average results across Victoria.

These AEDC results show a successful outcome for the Gannawarra Shire in addressing areas of vulnerability.

This result for Gannawarra indicates that current strategies regarding collaboration and partnerships within the sector, actively playing a role in service delivery and the bringing together of services locally has had measurable, positive impact.



Federal Government Policy

It is also worth noting that several federal government agreements underpin the development of the Gannawarra MEYP. At a federal level there has been recognition that investing in the early years improves outcomes for children, families and communities. These agreements include:

- The National Partnership Agreement on Early Childhood Education
- The National Quality Agenda for early childhood education & care
- Closing the Gap: National Agreement on Indigenous early childhood development
- The first National Framework for Protecting Australia's Children 2009-2020

STATE: State Government Policies and Planning

Since the introduction of Federal partnerships, much of the Victorian focus has been on the implementation of universal early childhood services and integration of these services.

These twin priorities have seen the development of a number of resources and funding programs by the State encouraging the construction of multi-service facilities or Hubs, including Maternal and Child Health (MCH), kindergarten, long day care, playgroups and other services.

State Government Early Years Strategic Plan 2014-2020

The recently released Early Years Strategic Plan provides a broad level commitment to a continued emphasis and priority on improving early years development practice throughout Victoria.

The Early Years Strategic Plan aims to improve outcomes and better support all Victorian children from pregnancy up to eight years of age with a focus across three areas:

- 1. Supporting parents and communities to give children a great start
- 2. Early and sustained support for those who need it most
- 3. All children benefiting from high-quality early learning.

Victoria's Vulnerable Children: Our Shared Responsibility Strategy 2013-2022

A key initiative of this document is the implementation of Area Partnerships. Gannawarra Shire will be a key agency in the Mallee Children and Youth Area Partnership.

Area Partnerships:


- are a critical step in establishing more effectively joined-up social services,
- take a holistic view of child vulnerability,
- will be a key mechanism by which the expectations for vulnerable children will be raised to that of other children, and

contribute to a collaborative and broad-based model of governance and

Ieadership that will help drive the Vulnerable Children's Strategy reforms.

Engagement with Aboriginal communities and Aboriginal community controlled organisations will be an Area Partnership priority.

Ensuring cultural responsiveness in the implementation of the *Vulnerable Children's Strategy* is critical to its success and that of the Area Partnerships.



LOCAL: Gannawarra Shire Strategy and Actions

Gannawarra Shire Five Ways To Wellbeing

The Five Ways to Wellbeing underpin the health and wellbeing directives of the Gannawarra Shire. And provide a foundation for considering how to support, engage and develop children living in the Shire. The five philosophies provide a holistic, "whole of person" approach to wellbeing and the aim is to create an approach to early years that deliver services, facilities and programs that encourage and engage children across these five areas.

Municipal Early Years Plan 0-6 Years (2011-2014)

The current MEYP has provided clear direction for Gannawarra Shire in being more directly involved in the delivery of services (particularly child care and kindergarten) within the Shire. Importantly the plan focused on several areas that continue to be a priority:

- 1. Leadership and service management
- 2. Educational programs and practice
- 3. Healthy lifestyles
- 4. Family Friendly Spaces
- 5. Professional Support
- 6. Collaborative partnerships

Early Years Think Tank

Since 2013, Council has initiated and coordinated the Early Years Think Tank to further enhance a partnership approach to early years health promotion and increase service coordination, with a particular focus on vulnerable children and families. Key directions from the Early Years Think Tank include:

- 1. Vulnerable family focus
- 2. Supporting transitions
- 3. Creating safe environments for service access
- 4. Developing trust and whole of community approach

Mallee Children and Youth Area Partnership (MAP)

With their work in developing the Early Years Think Tank, Gannawarra Shire will play a pivotal role in the MAP. The focus of the Mallee Area Partnership will include increasing the reach and effectiveness of prevention and intervention for vulnerable children and families through

- 1. Building the capacity of caregivers
- 2. Building the capacity of the service sector's access and responsiveness through increased service coordination and the identification of local barriers and action to overcome them; gaps and resources to fill them.
- 3. Strengthening the support for children to engage in learning and development.
- 4. Improving outcomes for children in out of home care.

Connect...

Take notice...





What we heard from our parents.

Education and Care...

Unsurprisingly, most education services were rated as highly important. Interestingly, childcare was rated as the second most important service but was also rated most highly as the service that parents would like better access to. (see highlighted graph below)



Recreation and Leisure.....

Libraries and playgrounds were both seen as important and as good quality facilities, however walking/bike paths were seen as most important and also the facility most in need of improvement. (see highlighted graph below)



Our parents conversations...

"I have one child attending preschool at Koondrook. If the service was available for longer hours that would help me with work....but a long day care on the days that he does not attend preschool or to extend the hours would be great."

"Long day care and family day is either not available in my area or limited"

"The Boort Dental Clinic offers a service to our family at minimal cost. A similar service should be on offer within Gannawarra Shire."

"Mental Health Services are extremely important over here, due to isolation and often no transport to get to facilities outside of town"

"Our local playgroup was an opportunity to meet other parents in the district where our children would interact with one another. Friendships were gained over time and continued throughout their school life."

"The Playgroup is run by volunteer mums with no support from Shire. It would be great to have support."


"Footpaths on both sides of Mitchell St."

"Opportunities for arts and culture activities"

Health and Wellbeing....

Health and wellbeing related services were rated as being important however only Maternal and Child Health services rated in terms of quality. G.P. and mental health services rated most highly with regard to services that needed to be improved. (see graph below)



Although 70 percent of parents who responded feel part of their community, 20 percent felt isolated as a parent and did not feel they had friends or family they could call on to help with child care.

Priorities for the next few years...

- 1. Increased childcare services and facilities was a common priority.
- 2. Improved facilities such as toilets at playgrounds, road crossings and footpaths, particularly to schools.
- 3. Improve promotion of parent network opportunities such as Library Rhyme Time, Playgroups etc.
- 4. More navigable website, better information distribution.

6 of the 12 services surveyed were either at capacity or had waiting lists for service delivery.

Only 4 services believed that families know what services they can contact for support.

9 services believed there was good communication between services and that services are good at connecting families to other support mechanisms.

10 services indicated that most families have to repeat their story every time they access a service.

6 services felt that more collaboration was a priority.

"I don't know that many families navigate the service system well. It is perhaps easier to find what's perceived as an essential service to the family, such as childcare."




