#### 7.4 ESTABLISHMENT OF MUNICIPAL EMERGENCY MANAGEMENT PLANNING COMMITTEE

#### **EXECUTIVE SUMMARY**

Changes to legislation, effective 1 December 2020, require Council to disestablish the existing Gannawarra Shire Municipal Emergency Management Planning Committee (MEMPC) and facilitate the establishment of a MEMPC in accordance with the provisions of the *Emergency Management Legislation Amendment Act 2018* (the EMLA Act), which inserts a new Part 6 (Municipal Emergency Management Planning Committees) into the *Emergency Management Act 2013*.

# **RESOLUTION**

### **That Council**

- 1. authorises the disestablishment of the existing Gannawarra Shire Municipal Emergency Management Planning Committee (MEMPC) established under s21(3)-(5) of the Emergency Management Act 1986, in recognition that on 1 December these provisions are repealed by s82(2) of the Emergency Management Legislation Amendment Act 2018 and replaced with the provisions of s68 of the Emergency Management Legislation Amendment Act 2018.
- 2. authorises the Chief Executive Officer to facilitate the establishment of a Gannawarra Shire MEMPC in accordance with the provisions of s68 of the *Emergency Management Legislation Amendment Act 2018* (which inserts a new 'Part 6 Municipal Emergency Management Planning Committees' into the *Emergency Management Act 2013* on 1 December 2020).
- 3. notes that in accordance with the *Emergency Management Legislation Amendment Act* 2018 (which inserts s59 and 59F into the *Emergency Management Act* 2013 on 1 December 2020), Council's role is to establish the MEMPC. Once established, the MEMPC exists separately to Council and is not a committee of Council.

### 7.6 QUARTERLY FINANCIAL REPORT - QUARTER ENDING 30 SEPTEMBER 2020

#### **EXECUTIVE SUMMARY**

At 30 September, 2020 Council is anticipating that the budgeted underlying surplus of \$1.154 million will increase by \$8k to an anticipated underlying surplus of \$1.162 million.

The budgeted Operating Result of \$7.944 million surplus will increase by \$496k to an anticipated Operating Result of \$8.440 million surplus.

Council's Capital Works program is progressing with an anticipated variation in scheduled works of \$808k. The adopted capital budget for 2020/2021 is \$17.504 million and it is expected to increase to \$18.312 million by 30 June, 2021.

The financial position of the Council remains stable.

Council officers have completed a tendering and evaluation process and seek approval from Council to appoint Haley Constructions Pty Ltd as the successful tenderer for the redevelopment of the Cohuna Skate Park.

#### 7.8 CARAVAN PARK REGISTRATION RENEWALS - COVID19 RESPONSE

#### **EXECUTIVE SUMMARY**

Re-registration of Caravan Parks with Council under the *Residential Tenancies Act (Caravan Parks and Movable Dwellings Registration and Standards) Regulations 2020* is due every three years. Renewal of registrations for the ten local caravan parks for the period 1 January 2021 to 31 December 2024 are due on 31 December 2020. Other registered businesses such as food premises, accommodation premises, hairdressing and beauty have received a 50% reduction in fees and charges for the 2020-2021 year. Applying a reduction of 50% to the first year applicable Caravan Park fee would ensure a consistent approach and recognise the impact local caravan parks have endured as a result of the COVID-19 pandemic.
