Energy was first raised as a potential economic generator back in 2010 as a way of making use of existing infrastructure to benefit the community and landowners. VNI West is the driver for 80% of the energy projects proposed and there will be significant financial benefits for landowners, community and Council. The projects will also provide economic benefits to accommodation, hospitality, retail and construction services and assist the local area to grow and prosper. Kerang has had transmission infrastructure since the mid 1960's and the community and farmers accept this as part of the local landscape that has had no adverse impacts.
