7 BUSINESS REPORTS FOR DECISION

7.1 QUARTERLY BUDGET REPORT - QUARTER ENDING 31 DECEMBER 2022

EXECUTIVE SUMMARY

At 31 December 2022 Council is anticipating that the budgeted underlying deficit of \$1.157 million will increase by \$873k to an anticipated underlying deficit of \$2.030 million. The deficit in 2022/23 is due to the advance payment of the Victorian Grants Commission 2022/23 annual allocation in April 2022 and depreciation being higher than anticipated as a result of the infrastructure revaluations as at 30 June 2022.

The budgeted Operating Result of \$7.522 million surplus will decrease by \$5.203 million to an anticipated Operating Result of \$2.319 million surplus. This decrease is due to the deferral of grant income anticipated to be recognised into 2023/24.

Council's Capital Works program is progressing with an anticipated variation in scheduled works of \$4.035 million. The adopted capital budget for 2022/23 is \$14.027 million and it is expected to decrease to \$9.992 million by 30 June 2023. This decrease is due to the delays in delivery of some major multi-year projects and also some projects awaiting confirmation of grants.

The financial position of the Council remains stable.

EXECUTIVE SUMMARY

This report has been prepared to present the Community Amenity Local Law for adoption by Council.

This is to replace the Local Law No. 1 Community Amenity 2012 which sunset in April 2022.

At its meeting held on 16 November 2022, Council resolved to endorse the draft Community Amenity Local Law for community engagement. Submissions closed on 20 January 2023. 73 submissions were received and considered at the close of the submission period with minor amendments made to the draft Local Law as a result of this.

7.3 KERANG LAKES ECO-TRAIL FEASIBILITY STUDY

EXECUTIVE SUMMARY

The Kerang Lakes Eco-Trail was identified by Kerang Landcare, with Council committing in mid 2021 to undertake a feasibility study into the project. After community consultation in early 2022 and site visits by the consultant, Tredwell Management Services, alongside regular input by Kerang Landcare members, the report has now been finalised. It indicates a significant capital investment of approximately \$12.5M to \$14.6M to construct the trail, and over \$50,000 to maintain each year, although the report does indicate this would have a positive economic impact, particularly during construction. Further planning and construction drawings will be necessary to finalise the proposed route and identify a more accurate costing of the project.

EXECUTIVE SUMMARY

Since September 2020, Council has been developing the Gannawarra Aquatic Strategy with consultancy firm Otium Planning Group. Council endorsed a draft Aquatic Strategy at its December 2021 Council Meeting and committed to undertake additional consultation in 2022. With the second stage engagement process undertaken, the Draft Strategy has been revised, and Council's commitment to adopt the revised Aquatic Strategy document is to be sought.

7.5 EXPLORING CARE AND EDUCATION IN COHUNA

EXECUTIVE SUMMARY

After receiving funding from the Victorian School Building Authority to explore care and education in Cohuna as a means to identifying a solution to childcare concerns within the Cohuna area, The *Exploring Care and Education in Cohuna* Report has been established. This report has been developed after significant local consultation, advice from key local stakeholders and has explored the various models and opportunities for care in Cohuna.

Importantly, the report has linked the Victorian State Government's Best Start Best Life early childhood reform highlighting that Council needs to improve kindergarten infrastructure in Cohuna to meet the needs of this reform. The report proposes the development of an Early Learning Centre in Cohuna located at the Cohuna Consolidated School which would enable Council to align with the State Government's future reforms for early years, and potentially access funding to construct the new facility.
