7.6 QUARTERLY BUDGET REPORT - QUARTER ENDING 30 SEPTEMBER 2025

EXECUTIVE SUMMARY

Council was last presented with its quarterly budget report in May 2025; this was for the March 2025 quarter.

As of 30 September 2025, Council is showing an underlying surplus YTD of \$11.451 million, which is \$1.108 million more than budgeted for the same period. Income has a variance of \$0.295 million, and there is a \$0.813 million variance for expenditure YTD.

Council is forecasting a \$4.474 million underlying deficit for 30 June 2026, which is an increase in the deficit of \$3.996 million on the 2025/26 adopted budget.

The adopted capital budget for 2025/2026 is \$19.320 million. There has been an increase in the forecasted capital works budget by \$1.481 million to recognise multiyear projects carried over from 2024/25. Anticipated budgeted spend by 30 June 2026 is \$20.801 million. 30% of the forecasted capital works budget had been committed by 30 September 2025.

7.7 COLLECTION OF UNPAID RATES UNDER S181 OF THE LOCAL GOVERNMENT ACT 1989**EXECUTIVE SUMMARY**

Section 181 of the Local Government Act 1989 (S181) outlines the process where Council may sell land to recover rates and charges that have been outstanding for more than three years. This is the last resort after all other Council rate recovery debt collection processes have failed and/or been exhausted.

The list in the report contains 49 properties with a total debt outstanding of just over \$575,000. This level of debt is to be addressed, as the current efforts to repay the debts are insufficient, which requires Council to commence the S181 action on these properties. The expected outcome will be that either the ratepayer will make payment of the outstanding rates or charges, or the property will be sold.

Council has engaged Executive Collections to assist with the debt collection processes of Council.
