#### **KERANG CBD REDEVELOPMENT - STAGE 3 WORK CONTINUES**

Improvements along Victoria Street, Kerang are continuing as part of the Kerang CBD Redevelopment - Stage 3.

Fully funded thanks to the Federal Government's Local Roads and Community Infrastructure Program, work completed so far as part of the \$2.31 million project includes improvements to car parking spaces between Scoresby Street and Victoria Square (right, top photo) and installing new paving along the eastern side of Victoria Street (right, bottom photo).

Work will soon begin on improving paving along the western side of Victoria Street, with shoppers to benefit from the installation of new outdoor dining areas, street furniture, and trees. Efforts will also occur to enhance the iconic Karlie McDonald Memorial Clock, located at the intersection of Wellington and Victoria streets.

### SEPTIC SYSTEM REQUIREMENTS

Onsite wastewater management systems, including septic tank systems, are used on residential, community and business premises in unsewered areas. They treat, recycle, or dispose of wastewater from bathrooms, kitchens, and toilets.

Poorly installed or maintained systems, especially older systems, can pollute nearby creeks and rivers, contaminate land and give off offensive odour.

If you own or use an onsite wastewater management system, there are laws that apply to you. These include:

- Operating the system correctly, such as not overloading it.
- Making sure the system does not overflow.
- Notifying Council if there is a problem with the system.
- Maintaining the system in good working order.
   This doesn't apply to renters.

If you're a landowner, it's recommended you get your system serviced regularly. You must also provide information to renters about how to use your system.



# ECONOMIC DEVELOPMENT

#### THE "BACKGROUND" TO VNI WEST

With there being plenty of interest in VNI West, it's important to understand the background to this project and the role it will play in the National Electricity Market (NEM).

In November 2020 the Federal Coalition Government and Victorian State Labor Government announced they would underwrite early works to progress the Victoria to New South Wales Interconnector project - with a preferred route known as KerangLink (VNI West). The then Federal Minister for Energy and Emissions Reduction, Angus Taylor said the support for VNI West will create new jobs, put downward pressure on prices, and shore up the reliability of the grid.



In April 2022 the Federal Coalition Government reached a \$75.8 million underwriting agreement with transmission provider Transgrid to deliver early works for VNI West. The agreement is the result of the Federal Government's plans to support critical energy infrastructure to ensure continued reliability of the national energy grid.

The Australian Energy Market Operator (AEMO) has determined a preferred route for the transmission line, which will be refined to a narrow corridor that will allow further investigation and further consultation with landowners. The proposed route will be made public once AEMO has consulted all landowners in the refined route.

Transmission infrastructure is very common in the Gannawarra, with the 220 kilovolt transmission line that has been in place since the 1960s having minimal disruption to farming. This line travels through irrigation and dryland cropping country and has long been accepted as part of the local landscape.

The 550-kilovolt line proposed as part of VNI West will be larger in capacity, with taller transmission towers proposed. The extra height of these towers will mean farming will continue as usual, with AEMO employing agricultural consultants to work with landowners to minimise any on farm disruptions.

Council staff will facilitate assistance to any landowners who are seeking advice and information and will provide introductions to relevant AEMO personnel. Copies of the landowner guide are available from Council's Customer Service Centre's in Kerang and Cohuna.

#### WHAT IS VNI WEST?

VNI West is a proposed new high capacity 500-kilovolt double-circuit overhead transmission line that will deliver vital new transmission infrastructure to connect Victoria, New South Wales and South Australia's electricity networks.

VNI West is expected to deliver up to 1,800 megawatts of additional electricity capacity between New South Wales and Victoria, generated via wind, solar and pumped hydro sources, and will provide greater flexibility across the network to share power resources between the states.

The project is one of numerous interconnector projects underway across Australia (left) to ensure the states' electricity networks are connected and can share power resources, especially as brown coal burning electricity stations start being phased out nationally.

#### WHY THE GANNAWARRA?

The Gannawarra Shire is located in the Murray River Renewable Energy Zone (REZ), which boasts wind, solar and battery projects capable of producing around 3,500 megawatts of electricity.

Renewable energy companies work directly with farmers to develop projects and to undertake a wide range of due diligence including network capacity and connections, environmental issues and community consultation prior to making application to the State Government for a planning permit.

Councils have no regulatory role in approving energy installations.

## FLOOD RECOVERY

## APPLY FOR A LEVEE MAINTENANCE PERMIT

Landowners who would like to access and maintain existing levees on Crown Land in order to actively reduce the flood risk to their property can apply for a Levee Maintenance Permit from North Central Catchment Management Authority.

Maintenance includes fixing erosion, dealing with rabbit burrows and removing vegetation. It does not include changing the levee's original location, height and width, building a new levee, or removing an existing one, as this could impact on the effectiveness of other levees in the area.

The permit can be issued for up to five years. However, the use of machinery and the introduction of any soil or other material must take place within the first 12 months of the permit. North Central Catchment Management Authority will work with land managers to set conditions to reduce the impact of works on the Crown Land and its flora and fauna.

## FLOOD RECOVERY



#### FLOOD ROAD REPAIRS CONTINUE ACROSS THE GANNAWARRA

Residents in Macorna, Macorna North, McMillans, Mincha West and Tragowel are benefiting from repairs to flood-damaged roads, made possible thanks to joint Commonwealth and State Government Disaster Recovery Funding Arrangements funding.

These works included maintenance grading and gravel re-sheeting, cleaning drainage structures, replacing a boxed culvert and re-instating a sealed roadway.

Work continues to gain government approval for the remaining 10 road repair packages which will enable residents to travel to and from their properties once works are completed via the quickest route possible.

Council will continue to provide updates regarding repairs to flood-damaged infrastructure via Council's website, the *Gannawarra News* and *Gannawarra Connect* publications, and Council's Facebook page.

Meanwhile, Council continues to advocate for repairs to occur along Regional Roads Victoria-managed roads in the municipality. These include the Loddon Valley Highway (B260), Murray Valley Highway (B400) and other local roads identified on maps or signage with a C2## prefix.

## FLOOD RECOVERY GRANTS PROGRAM

Thank you to community groups that submitted applications for the Gannawarra Community Flood Recovery Grants Program.

Twenty-two applications were received, valued at \$57,558.

Projects were assessed against flood recovery funding criteria, with successful projects announced at the end of August.

Not-for-profit community groups based in the Gannawarra that support Gannawarra Shire residents were eligible to apply for up to \$3,000 of funding to support projects that will assist the Gannawarra's recovery from the October-December 2022 floods.
