

#### Cobden Street to be improved

Gannawarra Shire Council has been awarded \$240,900 from the Heavy Vehicle Safety and Productivity Programme to



upgrade and improve access to the Quambatook rail loading and grain receival facility.

Council has been advocating and lobbying to the Government for this improvement for many years and we are very happy with the news of this funding.

This route provides an essential heavy vehicle transport link for local growers from all over the region to the grain receival complex.

The \$492,000 project, which includes a financial contribution from Council's 2016/2017 Budget, is anticipated to commence in August 2016 and be completed by March 2017.
