TEMPORARY LAKE CLOSURE

Notice is hereby given that Lake Charm will be closed to the public between the hours of 6.00 am to 6.00 pm on Saturday 27 May 2017. The purpose of this lake closure is for the Victorian Outboard Club Inc. Archer Eade Memorial event.

DECLARATION OF BOATING ACTIVITY EXEMPTION

Gannawarra Shire Council, as the declared waterway manager for the waters of Lake Charm under the Marine Safety Act 2010 (Act), makes the following declaration under Section 203(3) of the Act.

For the purposes of the boating activity by the Victorian Outboard Club Inc. on the waters of Lake Charm, vessels and persons competing in the Archer Eade Memorial event are exempt from:

- 1. The requirement to operate a vessel at a speed not exceeding 5 knots within 50 metres of another vessel, as detailed in Clause 2(c) of the Notice under Section 15(2) of the Marine Act 1988 (Vic);
- 2. The requirements of clause 139.9(b) of Schedule 139, waterway rules for Lake Charm, in relation to the area prohibited to vessels north of Boat Launching Ramp No.2 (provided all vessels maintain a speed that minimises wash when in this area).
- 3. The requirements of Regulation 96(6) and 100(3) of the Marine Safety Regulations 2012, in respect to PFD Type 1, PFD Type 2, PFD Type 3 definitions, the requirement to carry and to wear a PFD type specified. This exemption only applies to competing vessels with a reinforced cockpit, provided occupants wear an APBA approved PFD and comply with APBA rules.
- 4. The requirements of Regulation 44(2)(b) of the Marine Safety Regulations 2012, in respect to the requirements for holders of Restricted Marine Licenses to operate a vessel at a speed not exceeding 10 knots. This exemption only applies to competitors in:
- Formula Future J2 Class, provided they are over 12 years of age and do not exceed 27 knots;
- Formula Future J3 Class, provided they do not exceed

The exemptions apply from 6.00 am to 6.00 pm on Saturday 27 May 2017 provided the stated safety controls and undertakings detailed in the Event Application and APBA Rule Book are adhered to.
