Gannawarra Shire Council would like to hear from our residents regarding the 2025/2026 Proposed Budget, which invests in our community's needs.

The 2025/2026 Proposed Budget is financially responsible, and details the resource required over the next year to fund the large range of services we provide to our community.

The 2025/2026 Proposed Budget features a \$17.256 million capital works program, made possible thanks to support from the State and Federal governments.

One of Council's priorities is reducing the risks associated with future riverine and stormwater flood events, with funding allocated to flood betterment works, stormwater network and town pump renewals.

Other projects that feature as part of the capital works program include road safety improvements, Stage 2 of the Cohuna Waterfront Development and the completion of The Glasshouse @ The Gannawarra.

As part of the Proposed Budget, Council will also develop concept designs for improvements to the Cohuna and Kerang swimming pools.

We are aware of the financial pressure our communities are currently facing. As a result, the 2025/2026 Proposed Budget complies with the State Government's Fair Go Rates System, which states that the total revenue raised through municipal rates cannot increase by more than 3.00 per cent compared to the previous year. Council has also adopted a similar approach to our fees and charges.

STRATEGIC PROJECTS

- Cohuna Waterfront Stage 2 (\$3 million): Planned improvements to Cohuna's CBD and surrounds, building on the successful transformation of Apex and Garden parks. NOTE: Project dependent on successful funding application.
- Road safety improvements (\$2 million): Rollout of Transport Accident Commission Safe Local Roads and Street Programsupported projects to support various road safety improvements. NOTE: State Government-funded works.
- Cohuna and Kerang swimming pool designs (\$1.28 million): Development of designs, based on information in the Gannawarra Aquatic Strategy, to support the future redevelopment of the Cohuna and Kerang swimming pools. NOTE: Project dependent on successful funding application.
- Koondrook Levee Stage 1 (\$648,000): Construction of flood protection levee along Gunbower Parade, Koondrook, NOTE: Federal Government-funded works.
- The Glasshouse @ The Gannawarra (\$558,000): To be completed in 2025, this extension to Kerang's Sir John Gorton Library will support expanded Gannawarra Library Service programs and create additional community meeting spaces featuring current digital technology. NOTE: State and Federal government-funded works.

Council will continue supporting communities throughout the Gannawarra in the following ways

Community Grants program (\$50,000): Funding of up to \$5,000 per application for community projects that align with the Growing Gannawarra - 2021-2025 Gannawarra Shire Council Plan. NOTE: Applications for 2025 program are open 1-29 May.

A BUDGET THAT MAINTAINS A BALANCED RATING STRATEGY

Council is committed to adjusting the rating strategy to account for the current economic conditions. The property revaluation to be undertaken as at 1 January 2025 is included in the Proposed Budget.

Council is awaiting further valuation data for 2025/26 from the Valuer General's office. Calculation of rates in this Proposed Budget is based on the valuation figures to date and will change.

To achieve a budget rate increase that is considered fair and equitable for all rate payers, Council has increased the rates by 3.00%.


The Municipal Charge remains at \$100 and will be applied to all rateable properties.
