# 7 BUSINESS REPORTS FOR DECISION

### 7.1 QUARTERLY BUDGET REPORT - QUARTER ENDING 31 MARCH 2025

#### **EXECUTIVE SUMMARY**

Council's projected income forecast shows a variance of \$0.802 million, while expenditure reflects a forecasted variance of \$2.960 million. The budgeted Operating Result of \$20.696 million surplus will decrease by \$9.803 million to an anticipated Operating Result of \$10.893 million surplus.

This decrease is generated by flood funding expenditure carried over to 2024/25 as well as capital income reduced on multiyear projects transferred to 2025/26 for completion. Surplus funds arising from these deferrals have been strategically invested, generating additional income to assist in reducing Council's underlying deficit.

Council's Capital Works program is progressing with an anticipated variation in scheduled works of \$9.353 million. The adopted capital budget for 2024/25 is \$29.158 million and it is expected to decrease to \$19.804 million by 30 June 2025. This decrease is due to multiyear projects carried over to facilitate completion of these major project in 2025/26.

As of 31 March 2025, Council is anticipating an underlying result deficit of \$1.769 million.

# **10 QUESTION TIME**

### Question 1

What is the Gannawarra Shires current position on the proposed underground transmission line which is planned to travel down local roads and connect the proposed Normanville Energy Park to the Koorangie Terminal Station?

All local landowners have refused access to this transmission line as they oppose the project. Do you recognise this as a show of community opposition? Will you stand with neighbouring landowners who are clearly stating they are opposed by refusing power access? Allowing a developer to bypass all community feedback on the project and access public roads for transmission access could set a dangerous precedent for renewable energy in Gannawarra.

#### Answer

Gannawarra Shire Council acknowledges the question regarding the proposed underground transmission line associated with the Normanville Energy Park, which is planned to connect to the Koorangie Terminal Station. Large-scale renewable energy projects, including their associated infrastructure such as transmission lines, are determined by the Minister for Planning under Victorian legislation. The Council is not the responsible authority for planning approval of this project. The proponent has indicated its intent to install underground infrastructure within sections of Council-managed road reserves, including Denyer Road.

Council is aware of this proposal and, consistent with any other development or infrastructure project within the municipality, is currently engaging with the proponent through established internal processes.

Council's consideration of any request involving public land will be guided by the requirements of the Road Management Act 2004 and other relevant legislation. This includes assessment of road safety, asset protection, environmental impacts, and compliance with applicable standards. Council has not granted any final consent for infrastructure works within the road reserve at this time.

The proposed route has been presented by the proponent following its advice that access via private land has not been secured. Council's role is to manage any proposals concerning its assets in a lawful, transparent, and procedurally fair manner. Any decisions regarding access or agreements over Council-managed land will be made following due process, with Council maintaining its responsibility to protect public infrastructure and ensure regulatory compliance.

# Question 2

Has the Gannawarra Shire given any thought to producing some "housekeeping" rules for renewable energy developments in Gannawarra as some other shires have e.g. Yarriambiack?

We currently have a number of developers proposing projects with vastly different strategies. Minimum turbine setback distances from neighbouring houses is a huge area of concern. The developer of the Meering West project has stated he will apply at 2km set back to all neighbouring houses. In contrast, turbines in the proposed Normanville Energy Park are as close as 1.3-1.5km from multiple neighbours houses. If built, these houses will become unliveable. Has the shire fully considered the ramifications of families being forced to leave their homes? If Gannawarra is going to welcome renewable energy projects into the shire, it should be essential that developers and projects are required to conduct themselves in a consistent manner.

#### Answer

Council acknowledges the question regarding the approach to turbine setback distances in renewable energy developments and the request for consistent development standards. At present, the regulation of wind energy facilities in Victoria is governed by the Victorian Planning Provisions, including Clause 52.32, which mandates that wind turbines must not be located within one kilometre of an existing dwelling unless the written consent of the owner is provided.

The Minister for Planning is the responsible authority for such developments.

Council notes that different renewable energy proponents have proposed varied turbine setback distances, with some voluntarily adopting distances beyond the minimum required. While these proposals remain within the jurisdiction of the Minister for Planning, Council recognises the importance of consistent and transparent practices across all projects. Council does not currently have a locally adopted policy that mandates greater setback distances than those required under State planning provisions. However, Council is reviewing its position on renewable energy development frameworks, including the potential for local guidance to support community understanding and expectations, and to inform Council's input as a referral authority where relevant.

Council continues to support renewable energy development that aligns with State planning policy, while also ensuring that development proposals are implemented in a way that maintains public safety, protects amenity, and complies with planning requirements. Council will continue to consider options for advocacy or policy development to support consistent standards across projects, where permissible within the current legislative framework.
